MANUAL AMENDMENT BULLETIN #481

To All Bureau Members and Subscribers:

Re: Changes to Manual Rules - Forms

BACKGROUND

The Commissioner of Banking and Insurance has approved changes to policy forms in the New Jersey Workers Compensation and Employers Liability Insurance Manual (Manual). The changes are effective immediately on a new and renewal basis.

A New Jersey Notice of Cancellation or Material Coverage Change to Designated Governmental Entity Endorsement (WC 29 03 12) is added to the Manual as an optional endorsement to provide notification to the federal government of any cancellation or material change in coverage that may transpire during a policy term for policies insuring a government contractor, which notice is required by federal regulation (48 <u>C.F.R.</u> 28.302).

FORMS

Amend Section 3:2 to include a new endorsement, New Jersey Notice of Cancellation or Material Coverage Change to Designated Governmental Entity Endorsement (WC 29 03 12) is attached as Exhibit I.

The "Index – Policy Forms and Endorsements" is **amended** to reflect the above change. The amended Index is attached as Exhibit II.

With respect to policy forms, please note Section 3:2-1 of the Manual wherein the rules for the filing of forms are explained.
