Re: NEW JERSEY WORKERS COMPENSATION INSURANCE PLAN UPDATE AND PLAN POLICY EXPIRATIONS (July 2023)

Detailed data for Residual Market policies can be accessed on our website at <u>www.njcrib.com</u>. This information is published monthly to facilitate the depopulation of the Plan. The data identifies the employer, nature of the business and current estimated annual premium. Such premium includes the expense constant and the Plan Premium Adjustment Program, but excludes the Second Injury Fund and Uninsured Employers Fund surcharges. Experience rating data will be furnished upon written request in accordance with "Special Service Charges," Section 1:7 of the Manual.

The distribution of the July 2023 expirations by premium size is as follows:

The number of risks in the Plan on March 31, 2023 totaled 59,623. This constitutes an increase of 480 or 0.8% from the 59,143 risks in the Plan on February 28, 2023. There were 1,249 new policies and 769 withdrawals.

As of March 31, 2023, the estimated premium in the Plan totaled \$117,439,190. This constitutes an increase of 0.7% from the premium in effect on February 28, 2023.
